LEGIONELLOSIS OUTBREAK, PAHIATUA

Current situation

As has been reported in the media, there has been an outbreak of legionellosis among workers at the Fonterra Pahiatua milk-processing plant. Three workers at the plant have been confirmed with legionellosis since early October. Legionella contamination of cooling towers on the site has been confirmed, and has now been treated. The outbreak response is being managed by MidCentral DHB Public Health Service.

Clinical presentation

Legionellosis can commence with loss of appetite, influenza-like symptoms, fever, muscle aches and headache; dry cough, abdominal pain and diarrhoea can also develop. The illness ranges from a short-lived respiratory illness (Pontiac fever), to pneumonia (Legionnaires' disease) which can be severe. The incubation period for Legionnaires' disease is usually 2-10 days, up to 14 days.

Be alert for possible cases

Workers and contractors who have been on-site at the Fonterra Pahiatua plant between August and November have been advised of possible exposure to Legionella bacteria, and to seek medical attention if currently unwell or if an illness suggestive of legionellosis occurred between August and November. We ask that you have a high index of suspicion for legionellosis among those who have been on-site at Fonterra Pahiatua; recommendations for testing are on the next page.

If you suspect a case of legionellosis please:

- **Notify** suspected cases of legionellosis during office hours to the RPH notifications line on 04 570 9267, or after hours to the on-call medical officer of health on 04 570 9007;
- **Obtain** sputum for culture if possible
- Request urine testing for Legionella pneumophila serogroup 1 antigen if within one week
 of acute illness
- Request acute and convalescent blood specimens for legionella serology if within one
 month of acute illness; the convalescent specimen must be collected at least 3 weeks after
 the acute specimen
- Request a single convalescent specimen for legionella serology if more than one month since acute illness.
 - request acute and convalescent blood specimens for legionella serology;
 convalescent specimens are collected 3-6 weeks following acute specimen
- Copy all laboratory tests for legionellosis to "Medical Officer of Health" at Regional Public Health
- Manage as for the clinical presentation, for example as community-acquired pneumonia.
