Updated information for health professionals: ebola virus disease

The Ministry of Health has updated the advice on ebola virus disease (EVD) (version 04-06-15) for Health Professionals. This replaces the previous version circulated on 4 February 2015.

Changes to updated document:

- Minor updates throughout document to clarify intent or improve readability.
- The case definition has been aligned with those of other countries (i.e. temperature of 38 or higher specified).
- Redefined direct contacts as "high risk with PPE" and "high risk with no PPE" and clarified
 that contact with a case, infected body fluids, or a deceased case is required to be in this
 category; and only these two categories would be required to self-monitor.
- References to Liberia have been removed now that it has been declared ebola-free.
- Included in several places that a clinical assessment and monitoring by an ID or microbiology physician would be done prior to a person self-monitoring being declared a suspected case.

The Ministry of Health is no longer managing ebola readiness activities as an incident management team, however, international surveillance, enhanced border response, communications, and deployment coordination are continuing. The Ministry continues to undertake these activities and work with health and other sectors on readiness through an Ebola Project Team.

As of midnight Sunday 31 May 2015, border screening since 10 August 2014 has identified one hundred and thirty-nine (139) total passengers arriving in New Zealand who had been in an affected country within the previous thirty days.
